7.c Response Report

The Board discussed calls 25-054 and 25-055, C. Gerrits left the room due to a Pecuniary Interest with this business. The Fire Department will be issuing invoices for both calls since they are call 4 and 5 for false alarms. There was discussion regarding a few other calls, 25-045, 25-057 and 25-059.

7.d Budget Variance Report

The Board asked about the capital purchases line, why is it negative. The secretary/treasurer informed that this is because of the DC Cost Recoveries.

The Board have requested to have the Reserve Accounts added to the Budget Variance Report.

8. Fire Chief's Report

The Chief updated the Board regarding the radio project, it will be up and running effective May 6th. Communication between the firefighters is at its optimal due to the new tower. The trucks and the pagers are being worked on for the new system. Some of the old radios can be programmed to the new system, radios that cannot be programmed will be donated.

The Chief is getting quotes for two radios with screens, this will allow him to see the emergency prior to it being broadcasted by the dispatching department. The Tariffs will not effect Emergency Services.

A few of the new recruits have already left, the department is back to 35 firefighters. The Chief asked if there should be a stipulation when hiring volunteers that they must stay on for a period of time. The Board decided to leave it for now and see what the future holds.

Speed Camera in Town, how will this impact the Fire Department and the volunteers during calls. The Board directed staff to obtain the policy/By-Law from the Town of Grand Valley as well as from Wellington County and bring it back to next months meeting. The Board will then decide about creating a policy for fire trucks to be exempt.
